The closing time for receipt of tenders is **12h00 on Tuesday, 05 January 2016**. Telegraphic, telephone, facsimile and late tenders will not be accepted.

Tenders, completed as prescribed, shall be sealed in an envelope marked "**Project Name and Contract Number**" and must be deposited in the official tender box in foyer of Jozini Municipality Offices at Circle Street, Bottom Town, Jozini 3969. The Municipality will not be held responsible for any tenders delivered by courier services.
